You have been ordered by the Court to attend DUI Compliance court. Here is how to comply with all the court orders you were given today:

1. Sign up for **Work Release** or Supervised Electronic Confinement in the next **10 Days**

2. Call the **Orenda Center** and make an appointment within **20 days** of TODAY's date:

3. Sign up with the **Drinking Driver Program** within **21 days** of TODAY's date:
Orientation and DUI program sign-ups are held on Wednesday afternoons and Thursday evenings only (except on County holidays) at 1250 Coddington Center, Room A.

Wednesday afternoon: doors open at 12:30 p.m. for paperwork processing and are closed promptly at 1:00 p.m. Orientation is held between 1:00-2:00 p.m.

Thursday evening: doors open at 4:30 p.m. for paperwork processing and are closed promptly at 5:00 p.m. Orientation is held between 5:00-6:00 p.m.

Bring with you:

- o Current court referral document AND
- o Your program down payment in the amount of \$340 for the 18 Month Multiple Offender Program (no cash or personal checks accepted).

4. **Return to Court:** _____ at 2:00 p.m. in Department 15.

Bring with you:

- o AA sheet with the signatures for 3 AA Meetings per week.
- o Proof of enrollment in the Drinking Driver Program
- o Proof of enrollment in Work Release or Supervised Electronic Confinement.

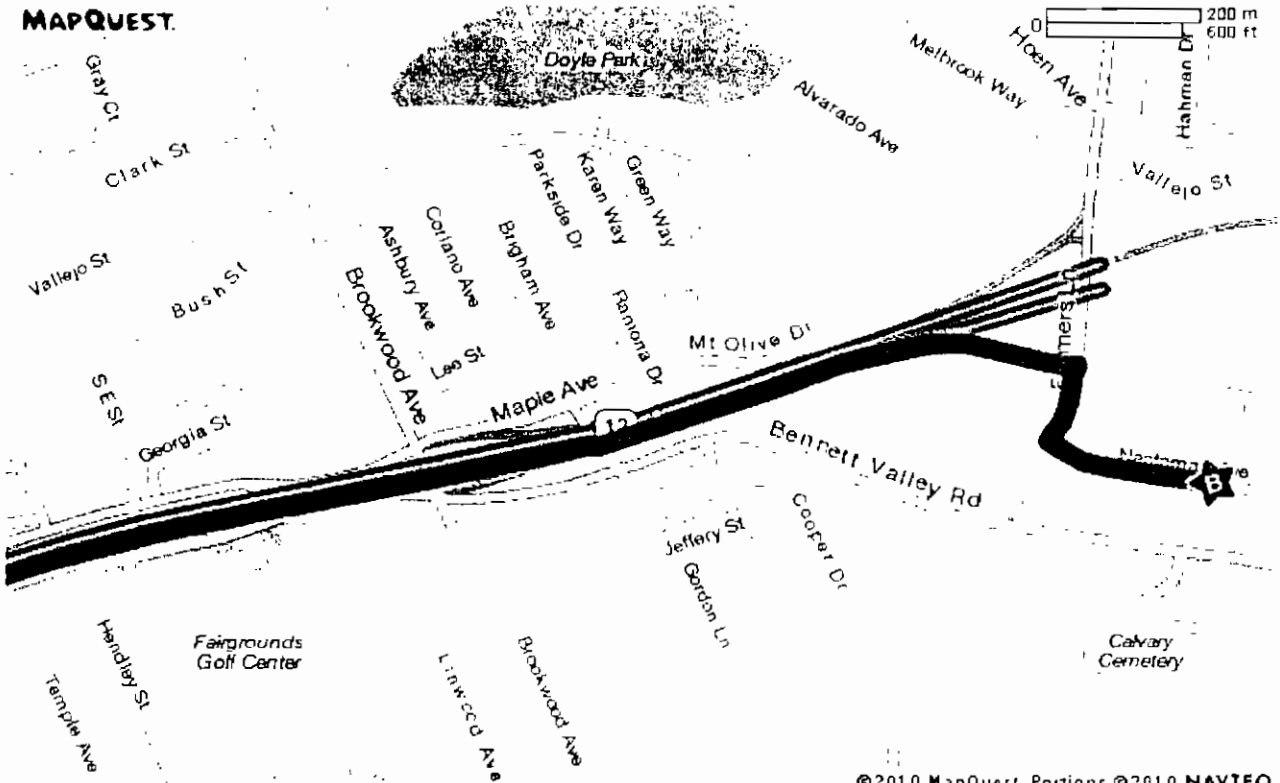

DUI Compliance Court (Tier 1)

Client Instructions

You have been convicted of a DUI and ordered by the Court to participate in DUI Compliance Court. You must do the following before your next court appearance:

1. Contact the Orenda Center to enroll in the DUI Compliance Court program.

Please report to the front desk at the Orenda Center to enroll in the program. Out-of-County residents may report to the Orenda Center by phone. Enrollment hours are between 12:30 pm and 4 pm, Monday through Friday.

***Please refer to your Court paperwork for the deadline upon which you must contact the Orenda Center. If you do not meet the deadline, you will be considered out of compliance with your terms of probation and will be subject to consequences.**

2. Once you report to the Orenda Center, you will be assigned a case manager. Orenda will assign you to either California Human Development (CHD) or to Drug Abuse Alternatives Center (DAAC). Once you have been assigned, the Orenda Center will instruct you on how to contact your case manager. Your case manager will help you with your next steps. Please bring your Court paperwork to your case manager on your first meeting. Your case manager will assist you in meeting the requirements and terms of your Court probation.
3. You have been scheduled for a DUI Compliance Court hearing. Your next hearing date is listed at the bottom of your Court paperwork, provided to you at the time of sentencing. If you need help finding your next court date, your case manager will assist you.
4. You will report to your case manager on the status of your terms of probation. You will show them proof that you have completed the tasks the Court has required of you.
5. At your DUI Compliance Court hearing, you will report to the judge on the status of your activities to meet your terms of probation (for example, have you signed up for the Drinking Driver Program? have you made a payment plan for your fines and fees? etc.).
6. If you are not in compliance and are not meeting the terms of your probation, the court will find you in violation and will determine the appropriate consequence.

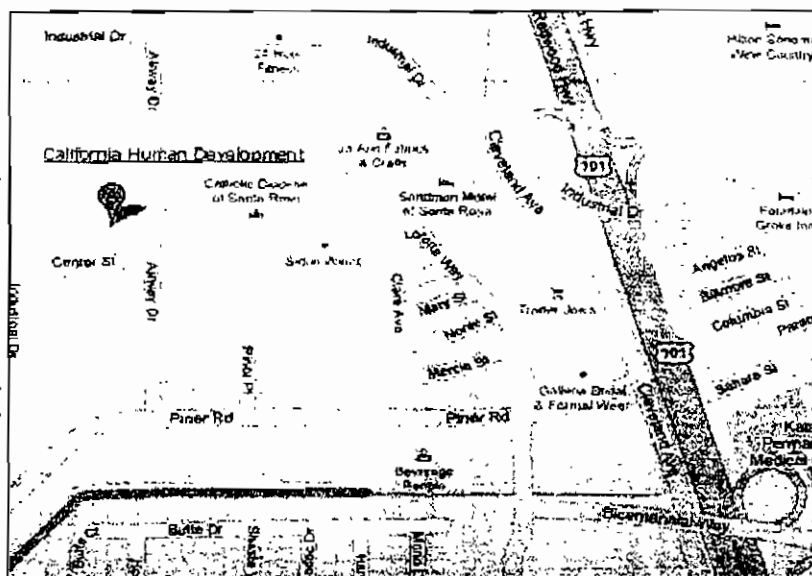

From North 101 - take the Hopper/Mendocino exit, turn right on Hopper Lane, turn left on Airway Drive and right on Center.

From South 101 - take the Bicentennial Avenue Exit and the West ramp, turn right on Range Avenue, turn left on Piner Road, turn right on Airway Drive and Left on Center.

From Coddington make a right on Range Avenue, turn left on Piner Road, turn right on Airway Drive and left on Center.
