22651(a)	Parked unattended upon any bridge, hazard
22651(b)	Parked or left standing on a highway, hazard.
22651(d)	Parked blocking a driveway.

22651(f)	Parked or left standing for more than four hours.
22651(g)	Driver injured or incapacitated.
22651(h)	Driver arrested.

## DESCRIPTION OF FEES AND AUTHORITY OF CHARGES

Name of Fee	Amount	Authority	Fee Description
Towing - Collected at Tow Company	See Tow Company	22850.5 CVC	The cost of the original towing performed by the tow company from the location the vehicle was stored or impounded to the storage facility.
Storage - Collected at Tow Company	See Tow Company	22850.5 CVC	The cost for the vehicle being stored at the storage facility for each calendar day the vehicle is stored or impounded.
Lien Sale Processing - Collected at Tow Company	See Tow Company	3074 CCC	\$70 for vehicles valued less than \$4000 dollars, only \$35 if the lien notice was not mailed. \$100 for vehicles valued \$4000 dollars or more, only \$50 if the lien notice was not mailed. This fee is charged to recover the costs associated with processing the lien.
Administrative Tow Fee - Collected at Police Department	\$140.00	22850.5 CVC	The cost recovery fee charged by the City to the vehicle owner for the administrative costs associated with the storage, impound, and release of the vehicle.
