In addition, any person who fails to appear as provided by law may be deemed to have elected to have a trial by written declaration (in absentia) pursuant to Vehicle Code section 40903(a) upon any allieged infraction, as charged by the arresting/citing officer

JUVENILE: If you were under age 18 at the time the citation was issued, you must appear in court with your parent or quardian.

COURTESY NOTICE: A courtesy notice may be mailed to the address shown on your citation, indicating the required deposit of money (bail) that may be forfeited instead of your appearing in court- if-you do not receive such courtesy notice, you are still required to comply with the items below by the appearance daté.-

- 2. If you contest the violation (select a or b):
- a. (Court trial) Send a certified or registered letter postmarked not later than five days prior to the appearance date or come to the court by the appearance date to request a court trial on a future date when an officer and any witnesses will be present. You may be required to submit the ball amount. Go online or call the court for information on going to court without paying ball. —OR—
- b. (Trial by written declaration (traffic cases) Send a certified or registered letter postmarked not later than five days prior to the appearance date or come to the court on or before the appearance date to request a trial by written declaration. Submit the ball amount. You will be given forms to allow you to write a statement and to submit other evidence without appearing in court. An officer will also submit a statement. The judicial officer will consider the evidence and decide the case.
